

GOOD AFTERNOON. THANK YOU FOR THE OPPORTUNITY TO ALLOW ME TO TESTIFY BEFORE YOU TODAY. MY NAME IS RYAN HARRIGAN AND I AM TESTIFYING BEFORE YOU TO EXPLAIN WHY I BELIEVE SUPPORTED DECISION-MAKING IS SO IMPORTANT TO ME.

I AM 30 YEARS OLD AND HAVE A DIAGNOSIS OF AUTISM. MY BRAIN IS WIRED DIFFERENTLY. SOMETIMES I LIKE TO REPEAT ' THOUGHTS, ESPECIALLY IF I'M NERVOUS AND ANXIOUS. THIS IS SOOTHING TO ME. I ALSO LIKE CERTAIN TOPICS, LIKE NAMES AND CARTOONS. THIS GIVES ME ORDER AND PREDICTABILITY IN MY WORLD.

I PRESENTLY LIVE IN AN APARTMENT IN SALEM AND HAVE ASSISTANCE WITH BUDGETING, GROCERY SHOPPING AND ORGANIZING MYSELF. I HAVE 2 JOBS – I WORK 1 DAY A WEEK AT PROJECT CHILLD IN PEABODY. THIS IS AN OCCUPATIONAL THERAPY CLINIC. I CLEAN THE EQUIPMENT AND SOMETIMES ASSIST WITH CLIENTS. I WORK 3 DAYS A WEEK AT CAMP FIRE. THIS IS AN AFTERSCHOOL PROGRAM IN SALEM. I DO ACTIVITIES WITH THE CHILDREN.

I LIVE A FULFILLED LIFE AND DO ACTIVITIES WITH FRIENDS AND FAMILY. I ALSO PARTICIPATE IN SPECIAL OLYMPICS AND RUN MANY RACES.

I AM MY OWN GUARDIAN. THIS IS VERY IMPORTANT TO ME. I HAVE WORKED HARD MOST OF MY LIFE TO BE AS INDEPENDENT AS IS POSSIBLE. I WANT TO MAINTAIN MY DIGNITY AND RIGHTS. I RECOGNIZE THAT I NEED ASSISTANCE WITH SOME DECISIONS SUCH AS FINANCIAL AND HEALTH ISSUES. I VERY MUCH WANT AND DESERVE TO BE INVOLVED IN THOSE DECISIONS.

IF THIS BILL BECOMES LAW, I WANT TO BUILD A SUPPORTED DECISION-MAKING TEAM. THE TEAM WOULD INCLUDE TRUSTED INDIVIDUALS AND MY PARENTS. WE WILL ALL HAVE PEACE OF MIND FOR MY FUTURE. AS MY PARENTS GET OLDER, THIS IS A MAJOR CONCERN FOR ME AND MY FAMILY.

I WILL NEED THIS TYPE OF SUPPORT THROUGHOUT MY LIFE. NATURALLY, I AM FEARFUL OF LOSING MY PARENTS. I WOULD FEEL MORE AT EASE IF I KNEW A TEAM OF TRUSTED SUPPORTERS WOULD BE AVAILABLE TO HELP ME WHEN NECESSARY. I WANT TO DO WELL. BUT I WANT TO BE THE ONE MAKING DECISIONS FOR MYSELF.

I RESPECTFULLY REQUEST THAT YOU PASS THIS LEGISLATION TO HELP PEOPLE LIKE ME NAVIGATE THE WORLD AND FEEL THAT OUR BASIC RIGHTS ARE PROTECTED.
